

# Climate Ready Hume project update

With the Hume Regional Climate Change Adaptation Strategy now complete, following a positive community consultation process, the Climate Ready Hume (CRH) team has developed this year's Yearly Delivery Plan. The plan outlines the key adaptation action activities for the next year with some of your favourite and most successful activities from previous years hopefully making a return!

## Release of the Productivity Commission report into National Water Initiative

The Productivity Commission's (PC) final report into Australia's progress towards reforming the water resources sector commissioned by the Commonwealth Government in May 2020 is now <u>available</u>. The report finds that "good progress" has been made against the National Water Initiative (NWI) reform agenda highlighting the "material benefits" that has lowered average water use by households, driven more efficient use by industry, provided more water for the environment, and enabled stakeholders to better adapt to uncertainty. The NWI is a shared commitment by Commonwealth, State and Territory governments, which aims to increase the efficiency of Australia's water use, provide investment confidence, supply security for rural and urban communities, and provide greater certainty for the environment.

Recycling Victoria: a new economy is the circular economy policy and 10-year action plan to deliver a cleaner, greener Victoria with less waste and pollution, better recycling, more jobs and a stronger economy. By 2046, Victoria is expected to produce 40% more waste than it did in 2017–18. If we don't act now this will put pressure on

#### Victorian Traditional Owner Cultural Landscapes Strategy has been launched

Victorian Traditional Owners recently launched the Victorian Traditional Owner Cultural Landscapes Strategy (Strategy), redefining the connection to Country for the world's oldest living culture. Facilitated by the Federation of Victorian Traditional Owner Corporations (Federation) and developed in Partnership with the Department of Environment, Land, Water and Planning (DELWP) and Parks Victoria, the Strategy is the first of its kind in Australia and sets out a framework to systematically enable Victorian Traditional Owners to lead planning and activate cultural knowledge and practices to manage Country. ## Solar on Public Buildings (SoPB) Update

The Solar on Public Building Program has been ramping up during July and August with several more sites receiving solar installations. Everton Upper Community Centre, Freeburgh Public Hall, Tatong Memorial Hall and Myrtleford Golf Club have received a total of 36.3 kW of solar PV (which is over 90 solar PV panels). These installs, funded by the Victorian Government's Solar on Public Buildings



program, are expected to save these volunteer community groups around \$8,000 each year in electricity costs, whilst also reducing green house gas emissions by almost 40 tonnes every year. That's about the same greenhouse gas emissions produce by 10 cars in a year! For more information please click here.

## Changes to the use of fruit netting

From 1 September 2021, netting used to protect household fruit-trees, vegetable gardens, or other fruiting plants must have a mesh size, of 5mm x 5mm or less at full stretch. If you use netting to protect your household fruit or vegetable harvest you will need to comply with this new mandatory requirement introduced under Victoria's Prevention of Cruelty to Animals Regulations 2019 (POCTA Regulations). Any existing household fruit netting that does not meet this specification must be

replaced with appropriate netting from the 1 September 2021 commencement date. For more information about the changes please click <u>here</u>.

#### Victorian Renewable Energy Target 2 (VRET2) Auction Now Open

The purpose of the second Victorian Renewable Energy Target Auction (VRET2) is to drive new investment, create thousands of jobs across the State and to help meet its commitment of sourcing 100% renewable electricity for all Victorian Government operations by 2025. The government is seeking a minimum of 600MW of new sources of renewable



energy. The VRET2 auction will close at 2pm on Tuesday, 9 November 2021. It is anticipated that the Victorian Government will announce the successful VRET2 projects around mid-2022. #### **Warby-Ovens Park earns international recognition**



Warby-Ovens National Park has become the first site in Victoria to be admitted to the International Union for the Conservation of Nature (IUCN) Green List of Protected and Conserved Areas – a global standard for nature conservation recognising the bestmanaged sites on the planet. The park was added to the Green List because of its outstanding natural values, including some of the

best examples of Box-Ironbark Forest and Riverine Forest and Woodlands in Victoria and world-class governance with input from Traditional Owners. The national park is a haven for nature lovers and offers a wide range of recreational, educational and social opportunities including bushwalking, birdwatching, cycling, camping and canoeing. ## **Australian Local Power Agency Bill 2021**

Dr Helen Haines, Independent MP for Indi, in February this year introduced the Australian Local Power Agency (ALPA) Bill 2021. ALPA was recently the subject of a public hearing held by the House of Representatives Standing Committee on the Environment and Energy. The Committee heard evidence from many of the individuals and organisations – such as Farmers for Climate Action, the Clean Energy Council, City of Greater Bendigo and Repower Shoalhaven — who contributed more than 1,000 submissions received on the bill over two weeks mid-year. #### **Investment Support Grants – Packaging**

The Investment Support Grant – Packaging (ISGP) supports Small and Medium Enterprises (SMEs), Not for Profits (NFPs) and social enterprises to pursue packaging waste reduction or recovery opportunities. The objective is to support businesses and



organisations that generate, recover or reuse packaging waste to transition to more circular business models or activities. The fund supports purchasing of equipment and infrastructure to enable and accelerate the diversion of packaging waste from landfill. ## Murray-Darling Healthy Rivers Program: Large Grants

The Australian Government is inviting applications for funding under the Large Grants stream of the Murray–Darling Healthy Rivers Program. There is \$10 million available in total funding for this round, with grants ranging between \$100,001 and \$2,000,000. This is an open, competitive grants round. Successful applicants will have 12 months to complete their grant activity from the date the grant

agreement is signed.

The intended program outcomes are:

- improved health and ecological conditions of rivers and wetlands in the Murray-Darling Basin
- improved community involvement in restoring the environmental health of the Murray–Darling Basin
- increased economic activity and employment in Basin communities as a result of grant funding. Applications close **6 October 2021**. The link is <a href="https://example.com/here/">here</a>.
